In connection with the conducted Pre-Bid Conference last November 17, 2020, 1:00 p.m., the National Archives of the Philippines through the Bids and Awards Committee hereby issues the Supplemental Bid Bulletin for the Procurement of Security Services for FY 2021.

I. CLARIFICATIONS

1. PhilHealth Computation

As per latest issuance of PhilHealth, Circular 2020-0014, Premium Rate Contribution for Direct Contributor is equivalent to 3.5%.

2. Statement of Ongoing Private and Government Contracts

Attached in Statement of Ongoing Private and Government Contracts are the Notice to Proceed and Notice of award.

3. Statement for Single Largest Completed Contracts

Attached in the Statement for Single Largest Completed Contracts are the contract, notice of award, notice to proceed and proof of satisfactory rating.

4. Cut-off for Clearances (Post Qualification Requirements)

The cut-off for Clearances stated under Clause 20 of Bid Data Sheet (BDS) of the Philippine Bidding Document is June 2020.

II. AMENDMENTS

1. Post Qualification Requirements

- d. *Certificate of PADPAO Membership*
- e. *Latest Clearances from the following agencies: (as of June 2020)*
 - *Social Security System*
 - *State Insurance / ECC*
 - *PhilHealth*
 - *Pag-Ibig*
- f. *Certificate of pending or no pending labor standards violations case/s issued by the National Labor Relations Commission (NLRC) and DOLE*
- g. *Certificate of Registration pursuant with DOLE Department Order No. 174*
- h. *Affidavit to provide employee's welfare*
- i. *Certificate of Satisfactory Rating from Three (3) Completed Government Contracts similar to the project*
