**Invitation to Bid for
RESTORATION AND CONSERVATION OF THE
INTENDENCIA BUILDING (Phase 1)**

1. The *National Archives of the Philippines*, through the *General Appropriation Act 2020 of the Department of Public Works and Highways (DPWH) through approved Fund Transfer to the National Archives of the Philippines (NAP)* intends to apply the sum of **One Hundred Forty Million Pesos (Php 140,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **RESTORATION AND CONSERVATION OF THE INTENDENCIA BUILDING (Phase 1)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *National Archives of the Philippines* now invites bids for the above Procurement Project. Completion of the Works is required **Two Hundred Eighty-Five (285) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *National Archives of the Philippines* and inspect the Bidding Documents at the address given below from **Monday to Friday, 8:00 a.m. to 5:00 p.m.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **January 22, 2021** from given address and website/s below **Fifty Thousand Pesos (Php 50,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

The *National Archives of the Philippines* will hold a Pre-Bid Conference¹ on **February 1, 2021, 1:30 p.m.** at **NAP Audiovisual Room, PPL Building, 1000 U.N. Avenue corner San Marcelino Street, Manila** and/or through videoconferencing/webcasting via **Zoom (meeting ID: 925 2765 9258)**, which shall be open to prospective bidders.

6. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below on or before **February 15, 2021, 12:00 noon**. Late bids shall not be accepted.
7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
8. Bid opening shall be on **February 15, 2021, 1:30 p.m.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
9. The **National Archives of the Philippines** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
